CENTURY CLUB

Century Club donations are annual donations provided by an individual, business, or organization. Although a Lion or Lioness Club may not be a Century Club Member as a whole, members may participate individually. All Century Club contributors receive a lapel pin and a wall plaque. Century Club donations may be paid as a single sum or via monthly bank drafts.

100 % - 1000 % PARTICIPATION

In each year that a Lions Club contributes \$10.00 per member, that Lions Club earns the distinction of 100% Participation for that year. Twenty dollars per member will earn 200 %, \$30.00 dollars per member will earn 300 %, etc. Banner patches for the year are given to the clubs for 100 % participation. Chevrons are given to the clubs for 200 % participation, 300 % participation, etc., as well as for every consecutive five years of participation. A certificate is given to the club president for 200 % participation or greater.

HONORARIUMS

A donation may be given to the Camp in honor of a living person. An Honorarium can be given in appreciation to guest speakers or for a birthday, anniversary, Christmas, or other giving opportunity. The honored person will be sent an Honorarium Plaque if the donation is \$150.00 or more.

LIFE MEMBERSHIPS

All persons who donate \$100.00 or more can request that the money be designated for a Life Membership at the Camp. All individuals who become Life Members receive a lapel pin and a certificate. If the donation is \$125.00 or more, the Life Membership certificate is mounted on a plaque. An individual may receive more than one Life Membership. Organizations and businesses may also purchase Life Memberships. Although a Lions Club may not be a Life Member as a whole, club members may participate individually. Clubs honor outgoing presidents and others with Life Memberships. Clubs also honor surviving spouses or family members with Life Memberships in memory of the deceased.

MEMORIALS

A donation may be given in memory of a deceased person. An acknowledgment is sent to the donor, as well as to the family of the deceased. With a donation of \$150.00 or more (or amounts which cumulatively total \$150.00 or more), a memorial plaque is forwarded to the surviving spouse or nearest relative.

MEMBERSHIP DUES

\$6.00 per Lions Club member is paid semiannually. Clubs are notified of their dues amounts by the District. The first payment is due by September 10, and the second is due by March 10. Checks are made payable to the Texas Lions Camp and then mailed to the District Treasurer, who records them before forwarding them to the Camp.

DONATIONS

All undesignated gifts from individuals, organizations, corporations, and foundations are recognized with an acknowledgment letter that is sent to the contributor.

With the exception of Century Club donations, credit will be given to Lions Clubs for all donations listed above. For all contributions, please indicate the club and district which is to receive credit.
