## **Century Club**

Century Club is for everyone, Lions, other individuals and even businesses. It is a monthly donation paid with a check or bank draft, or an annual one-time payment. The levels per year are \$100 for Bronze; \$250 for Silver; \$500 for Gold; \$1000 for Diamond and \$5000 for Ambassador. The donor is sent a plaque and annual medallions to mark Century Club participation. Plus, a lapel pin to show membership.

### **100% - 1000% Participation**

A Lions Club contributes \$10 per member and receives recognition as a 100% Participation Club for that year. With \$20 per member, the club is recognized as a 200% Club on up to 1000% Participation, and so on. A certificate is awarded to the club president for 200% Participation or higher. Banner patches and chevrons are awarded to the club to mark its 100% - 1000% participation.

### **Honorariums**

A Donation may be made in any amount to the camp in honor of a living person. The honored person will be sent an Honorarium Plaque if the donation is \$150 or more.

### **Life Memberships**

Life Memberships are open to Lions, other individuals and businesses. For a donation of \$100 or more, a life membership to the camp can be awarded to an individual for service, honor or as a memorial. A lapel pin and certificate are awarded to the recipient. If the donation is \$125 or more, the certificate is mounted on a plaque. Although a Lions Club is not allowed to receive a Life Membership, individual members may receive more than one Life Membership.

### **Memorials**

A memorial given to honor someone who is deceased can be made in any amount at any time to the camp. An acknowledgement is sent to the donor as well as the family of the deceased. If the memorial is \$150 or more a plaque is forwarded to the family of the deceased if requested by the donor.

### **Membership Dues**

Semiannual dues of \$10.50 is paid by each individual Lion Club member, usually in September and March. Clubs are notified by the District, and all funds funnel through the District Treasurer then to the Texas Lions Camp.

### **Donations**

All undesignated gifts from individuals, organizations, corporations, and foundations are recognized with an acknowledgement letter that is sent to the contributor.

With the exception of Century Club donations, credit will be given to Lions Clubs for all donations listed above. For all contributions, please indicate the club and district which is to receive credit.
